### **INTRODUCTION**

The Kenya Electricity Transmission Company Limited (KETRACO) is a 100% state-owned corporation incorporated on 2<sup>nd</sup> December, 2008 under the Company's Act, Cap 486 as a State Corporation pursuant to the Sessional Paper No. 4 of 2004 on Energy. The Mandate of the Company is to plan, design, construct, own, operate and maintain high voltage electricity transmission grid and regional power interconnectors.

KETRACO's Vision is to provide a Stable Power Grid that will Transform Lives in the Region and Beyond. The Mission of the Company is to provide a stable electricity grid and facilitate power trade for sustainable socio-economic development.

The Company invites applications from suitable individuals to fill the following positions: -

#### **Job Purpose**

This job is responsible for assisting in all substation and transmission line projects with regards to all civil & structural engineering related works of transmission system projects, for a reliable, efficient and effective electricity transmission infrastructure.

#### **Key Responsibilities**

- i). Implementing quality control on matters relating to substations and transmission lines during procurement, design and commissioning of transmission and substation projects;
- ii). Undertaking designs and design reviews of substation and transmission line projects in liaison with the other relevant divisions and stakeholders to support timely delivery of quality transmission system projects;
- iii). Assisting in monitoring implementation of approved designs and specifications during implementation of substation and transmission line project works;
- iv). Assisting in enhancing quality of substation and transmission line projects by referring to and adopting relevant/applicable standards/manuals/codes and methodologies

- during design of power transmission system project to ensure quality design documents;
- v). Assisting in implementing technical guidelines and standards/manuals for substation and transmission line project designs and preparation of bidding documents and request for design proposals;
  - vi). Working with local and international design Consultants for stand-alone outsourced design services;
  - vii). Assisting in preparing periodic design status reports of projects to the Senior Engineer / Manager, Civil & Structural Design as shall be directed;
  - viii). Assisting in reviewing technical substation and transmission line engineering information to be shared with contractors and subcontractors to ensure projects comply with engineering standards, codes, specifications and design instructions / requirements;
  - ix). Assisting in implementing document control and archiving of approved and as built design documents and drawings as well as test reports for transmission line and substation projects;
  - x). Assisting in reviewing consultants' designs to ensure that their designs conform to company standards and international standards;
  - xi). Participating in design interface meetings with consultants and contractors, as required;
  - xii). Participating Factory Acceptance Tests, material testing and final Acceptance of transmission lines and substation projects.
  - xiii). Participating, Supervising and Coordinating site testing and acceptance of all related works of substations and transmission lines.
  - xiv). Complying with relevant acts including Energy Act, Procurement Act, Engineers Act; Environmental Act, Health and Safety Act among others;

#### **Qualifications & Skills required:**

- i). A Bachelor's degree in Civil Engineering or related field from a recognized institution.
- ii). Registered Graduate Engineer with Engineers Board of Kenya (EBK);
- iii). Graduate Member of the Institution of Engineers of Kenya (IEK);
- iv). A minimum of three (3) years' relevant work experience. Having demonstrable experience in substation or transmission line projects setting will be an added advantage.
