The Mandate of the Company is to plan, design, construct, own, operate and maintain high voltage electricity transmission grid and regional power interconnectors.

KETRACO's Vision is to be a world-class electricity transmission company and the leading interconnector in Africa. The Mission of the Company is to provide reliable, efficient and effective electricity transmission and promote power trade for sustainable socio-economic development.

Job purpose

This Job is responsible for providing leadership and coordinating information technology and innovation systems technology in order to facilitate stable and reliable operation of the Company's ICT Infrastructure and Service Delivery. The Job holder undertakes development, maintenance, support, and optimization of ICT Infrastructure, Local Area Networks, Wide Area Networks, Data Centre, Disaster Recovery Site, corporate data backup and Internet connectivity.

Key Responsibilities;

- i. Designing and executing short and long-term strategic plans to assure infrastructure capacity attains current and future needs.
- ii. Developing and executing procedures, policies and related training plans for project management and infrastructure administration.
- iii. Managing and establishing priorities for maintenance, design, development and analysis of entire infrastructure systems inclusive of LANs, WANs, internet, security and wireless implementations.
- iv. Leading research and recommend changes in services, products, protocols and standards to support development efforts and infrastructure procurement.

- vi. Defining standards for physical and logical infrastructure in collaboration with stakeholders.
