#### Job purpose

This Job is responsible for applying technical knowledge in planning the determination of end-to-end design requirements for new and enhanced functionality for ERP modules, Finance and Controlling, Materials Management, Human Capital Management, Project Systems, Business Intelligence and ABAP, in liaison with business units, business analysts and vendors. The job owner drives the definition of requirements, development of functional designs based on the analysis of business needs, objectives and existing system infrastructure in coordination with business analysts and system Analysts.

- i. Representing the unit in external and ad hoc assignments relevant to the unit's work as and when required by the Information Technology and Innovation Manager, Business Applications.
- ii. Mentoring and coaching business analysts to ensure that best practice is adhered to.
