# RE: TENDER ADDENDUM AND CLARIFICATION 1FOR SUPPLY OF SPARES FOR EMERGENCY REPLACEMENT FOR POLE 2 VALVE EQUIPMENT AT SUSWA CONVERTER STATION (KETRACO/PT/002/2025).

The following amendments are made to the specified provisions of Tender for Supply of spares for emergency replacement for pole 2 valve hall equipment at Suswa converter station. (KETRACO-PT-002-2025). Save where expressly amended by the terms of this clarification, the Principal Tender Document shall continue to be in full force and effect.

#### **Technical Requirements**

### The technical criteria 3.4.5 and 3.4.8 have been revised as follows:

- 3.4.5 Bidders are requested to provide both the supplier's and bidder's valid ISO 9001 certification.
- 3.4.8 Bidders are requested to provide evidence of their involvement in the supply of items from original equipment manufacturer's factory in the form of LPOs, Contracts or Completion Certificates for the past five years (2020 to 2025). Bidder to submit at least two (2) separate LPOs, Contracts or Completion Certificates each with a value of at least eighty-four million kenya shillings (KES. 84,000,000). The contact and email addresses on the documents should be correct for verification purposes.

#### The technical criterion 3.4.9 below has been added.

3.4.9 Bidders to provide a duly filled and stamped TDS to show compliance with the environmental requirements.

#### Financial Evaluation

## The financial criterion 3.5.2 has been revised as follows:

3.5.2 The bidder shall provide Audited Financial Statements. The audited financial statements required must be those that are reported within the last 3 years. (For companies or firms that are registered or incorporated within the last one calendar year of the Date of the Tender Document, they should submit certified copies of bank statements covering a period of at least six months prior to the date of the tender document. The copies should be certified by the Bank issuing the statements. The certification should be original). Firms must have a minimum Average Annual Turnover of KES 100,000,000 or a bank balance of KES 20,000,000 in case the Certified bank statements are issued.

The tender closing date has been extended to 18th March 2025 at 10.30 AM. All other terms and conditions of the tender document remain the same.
